Safeguarding and child protection is the most important issue for our children and young people. At St Oswald's we feel it is crucial to work with our parents and the agencies that support schools and young people so that we can offer a safe environment allowing children to be aware of the risks they may face and how to respond to them safely.

Safeguarding is Everyone's Responsibility and we take the approach 'It could Happen Here.'

Keeping Children safe in Education 2023 (KCSiE)

reminds us that safeguarding and promoting the welfare of children is everyone's responsibility.

The theme for this year is; Inspiring Change? making a difference, managing influence and navigating change online.

Safer Internet day is the UK's biggest celebration of online safety. Each year we cover an online issue of theme that speaks to the things young people are seeing and experiencing online. This year it includes;

- Young people's perspective on new and emerging technology.
- Using the internet to make change for the better.
- The changes young people want to see online
- The thing that can influence and change the way young people think, feel and act online.

Things change so fast online, it's hard to keep up with what my child is doing

Staying up to date with what children are doing online can feel like a challenge sometimes. However, you don't have to be an expert in every new app or service. Simply having conversations with your children about their lives online, and what to do if they need help or something goes wrong, is what's most important. Here are a few simple steps you can take to help bridge the gap

Talk little and often

Having a regular open dialogue with your children about their favourite apps, the games they enjoy, and their online friends, will help create an environment where chatting about online experiences becomes a normal part of family life.

Stay proactive

As a result of discussions with your children about their online activities, take time to research the apps they're using, the accounts or channels they're following, and the games they're playing, to get a better idea of what they're experiencing and what your thoughts are towards it.

Seek support

Knowing where to get help is essential. Each app or platform will have its own safety guidelines and reporting features, and having knowledge of how to use these will ensure you can make a report, seek help, and support your child to get the best out of the services they're using.

Water Safety

Following on from the increased rainfall locally please keep an eye out for fast moving water.

The Royal Life Saving Society UK report that drowning is the third highest cause of accidental death of children in the UK and that a person can drown in as little as 2cm of water.

The water safety code: Water may look safe, but it can be dangerous. Learn to spot and keep away from dangers. You may swim well in a warm indoor pool, but that does not mean that you will be able to swim in cold water.

The dangers of water include:

- it is very cold
- there may be hidden currents
- it can be difficult to get out (steep slimy banks)
- it can be deep
- there may be hidden rubbish, for example shopping trolleys, broken glass
- there are no lifeguards
- it is difficult to estimate depth
- it may be polluted and may make you ill

- Achieve to their full potential.


• Minimise the risk of engaging in anti-social behaviour and becoming victims or perpetrators of crime.
